Progress on Action Items from the ERSWG 14 Workplan (ERSWG Agenda Item 4)

Introduction

The last meeting of the Ecologically Related Species Working Group (ERSWG 14) was held from 21-25 May 2022. That meeting developed a workplan for activities to be conducted between ERSWG 14 and ERSWG 15. This paper provides a brief update on progress with the workplan.
